Lenalidomide ViatriS (lenalidomide) Capsules
– NZ-Specific Cartons

Dear Healthcare Professional,

We are writing to provide you of an important update regarding Lenalidomide ViatriS (lenalidomide) Capsules (provisional consent) sponsored by ViatriS Ltd.

All marketed strengths of Lenalidomide ViatriS (5 mg, 10 mg, 15 mg, and 25 mg) have had the existing cartons updated to include a red box warning for the dispensing pharmacists. The product will be switching over to this new carton.

The additional wording added to the cartons is a reminder to pharmacists to check the authorisation code and pregnancy status of the patient (as applicable) before dispensing using ViatriS Care program accessible via <https://www.viatriScare.co.nz/>

There are some minor updates to how the information is expressed on the carton and foil. There is no change to the formulation.

The updated cartons are expected to be in the New Zealand marketplace from late September 2025.
